#### CONDITIONS OF CERTIFICATION

1. When applied to a non-combustible substrate
2. PVC based floor covering consisting of: urethane acrylic surface coating roller applied at a rate of 12g/m<sup>2</sup>, plasticised PVC clear wear layer 'Marine Clear Wear-layer' 520µm thick, print film layer 'SW2504' 75µm thick, filled plasticised PVC core layer 'Marine Filled Core Layer' 760µm thick, filled backing layer 'Marine Filled Backing Layer' 500µm thick
3. Total thickness of floor covering 2.0mm, total weight 2.55kg/m<sup>2</sup>
4. Floor covering adhered to substrate with 'Amtico Universal 2-Part' polyurethane adhesive by trowel at application rate 2.0 – 2.5m<sup>2</sup>/kg. The following adhesives may also be used: 'Amtico PS Adhesive', 'Amtico HT', 'Amtico SF Plus Adhesive', 'Kiilto M1000' adhesive, 'SF Adhesive'
5. Composition of individual coatings and adhesives, including any fire retardants, to be maintained in production in accordance with originally tested composition formula
6. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype
